# Summary

Bijan Mohseni-Calderón is a labor and employment, civil rights, and constitutional attorney, an elected Delegate to the California Democratic Party, and a former Democratic Candidate for California State Assembly.

He is a proud first generation American and is the first in his family to graduate from college.

Bijan is a Labor & Employment Attorney that specializes in defending the civil rights of victims of discrimination and harassment in the workplace.

Bijan was previously an associate attorney at two AmLaw 100 firms, Latham & Watkins and Lewis Brisbois. While at Latham, Bijan helped represent civil rights organizations in impact constitutional litigation on a pro bono basis, including Equality California and seven transgender individuals challenging President Trump's ban on transgender service members in the military before the United States Supreme Court. Bijan has also helped represent asylum seekers and victims of human trafficking obtain lawful status through U Visas and T Visas, assisted transgender and nonbinary individuals change their names and gender markers, and aided the rehabilitation of people convicted of low-level offenses by helping them overcome barriers to employment. He was awarded the Equality California Community Leadership Award and the Latham & Watkins Guardians of Justice Pro Bono Award.

While in law school Bijan worked for United States District Judge Josephine L. Staton of the United States District Court for the Central District of California, and for Justice Brian M. Hoffstadt of the California Court of Appeal, Second District.

Prior to the start of his legal career, Bijan worked for four years on the sales and marketing side of the fashion industry for notable brands like Porsche Design, Ted Baker London, and Montblanc.

Following his Southern California public school education, Bijan completed his Bachelor of Arts degree in Political Science at Chapman University and received his Juris Doctor degree from UCLA School of Law. Bijan also studied Politics and Philosophy at the University of Oxford. His areas of research and scholarly interest include 2nd Amendment Jurisprudence & Policy, and Constitutional Law & Theory. He is an accomplished vocalist and has studied music classically for over 20 years. In 2010, he was awarded the Gold President's Volunteer Service Award by President Barack Obama.


